DIAMOND CUT CONCRETE . WE WILL REMOVE ENTIRE SLAB SECTION SO SIDE WALK (APPROXIMATE 3 FOOT BY 4 FOOT) WHERE NEEDED TO TIE INTO MAIN 8 INCH LINE. WE WILL DISPOSE OF CONCRETE AFTER WE REMOVE IT. WE WILL MAKE 3 CONNECTIONS FROM 4 INCH INTO NEW 8 INCH MAIN WHICH WILL DISCHARGE THROUGH NEW BULKED . WE WILL ALSO INSTALL 2 CONNECTIONS INTO A 6 INCH NEW MAIN WHICH WILL DISCHARGE THROUGH BULKED.
